What could go wrong? What hazard have you identified? What are the risks from it?	Who is at risk?	What are you going to do about it? How are the risks already controlled? What extra controls are needed? How will they be communicated to young people and adults and remain inclusive to all needs?	Review & revise What has changed that needs to be thought about and controlled?
Slips, trips and falls in and around the activity resulting from uneven ground, holes and wet conditions underfoot.	Leaders / Young Leaders Participants	Check the surrounding area during pre-start inspection. Remove any foreign objects which might cause injury to participants. Advise the Green Beret management team of hazardous ground conditions which need to be made good. Brief Leaders, Young Leaders and participants of any residual risk.	Keep under review during the activity.
Falls from height during activity.	Participants	Maximum of two people on the van roof at any one time. Participants do not jump from the top of the van. All activity rules will be covered during the pre-start activity safety briefing. Ensure ground conditions alongside the van are free from obstructions and holes to avoid twisted ankles and injuries to feet and hands.	Keep under review during the activity.
Manual handling of climbing panels.	Leaders / Young Leaders	The climbing panels which protect the van are large and heavy and contain bolts and other protruding elements. Leaders will wear gloves during installation and removal of the panels to avoid injuries to hands. Ensure an adequate number of leaders are available to safely lift the panels. One leader will take control and manage the panel installation and lift.	N/A
Inadequate lighting during night activity.	Leaders / Young Leaders Participants	Ensure adequate lighting is provided during the hours of darkness. If lighting levels are not adequate, the activity will be stopped.	Monitor light levels during the activity.
Ill health from poor weather.	Leaders / Young Leaders Participants	Leaders and Young Leaders will wear suitable warm and waterproof clothing including boots or wellies. Warm drinks and snacks will be provided to Leaders and Young Leaders running the base.. Participants will be briefed by their own Scout Groups on the need for suitable clothing (action by others).	Keep under review during the activity.
Minor physical injuries requiring first aid treatment.	Leaders / Young Leaders Participants	There is a risk of minor injuries to hands and fingers during the activity. This risk will be included in the pre-start safety briefing, given to all participants. First aid kits will be available locally and any serious injuries will be taken to the Green Beret first aid team for treatment.	N/A
